THE "FIFTH SCENARIO" * WORLD NEW ENERGY ORDER THE RESOURCES – MUTUAL PROPERTY OF THE MANKIND

"Mankind could have a future, only if constructive efforts are made today..".

Today a barrel of oil effortlessly exceeds 100 US dollars. The price for a cubic meter of natural gas creeps-up constantly.

Years ago famous geologist, scientist and a public figure Jeremy Leggett in his work "The end of competition" has stated that a price tag of 100 US dollars for a barrel of oil will become a symbol for the beginning of the final chapter of a spiral of psychological, economical and political shocks, possibly leading to revolutions and wars.

Now we cannot claim anymore, that the price of oil increases only speculatively and hope for a day to see it move back down. Expectations for drastic increase of oil production by OPEC and other oil producing countries appear to be unrealistic. There are different reasons for that — a depletion of major oil fields, as well as the need for massive financial investments and time necessary to start exploitation. Furthermore not to forget that many of the oil fields regions are constantly arenas for international and/or religious conflicts, terrorists' acts or are located in ecologically sensitive areas.

Keeping low oil prices until 1999 discouraged oil producing countries and companies to invest (to search for new oil fields as well as refineries). The conclusion is that incentive for investments are justified when the price of oil is high. Today we witness this phenomenon. Are those higher prices going to prevent a crisis?

In the conditions of restructure of dynamic world economy – US, The European Union, Far East Countries, Japan, India, Brazil and specifically China but why not and Africa will absorb in addition colossal quantities of energy – oil and natural gas.

One comparative analysis from the 1990-ties shows that South Korea was consuming 17 barrels of oil per year for each person and China only 1 barrel! During the next 20 years, the oil consumption in China will increase to 30 billion barrels annually. Currently OPEC's production amounts to slightly over 10 billion barrels per year. And these calculations are realistic and do not include the consumption of the Far East countries, EU, USA, India, Brazil and rest of the world.

There is one conclusion: the oil resources are limited (they may not be reproduced) and becoming more expensive and from the other side the ecological and genetic (for the nature and mankind) consequences of their consumption becoming more dramatic. Even if the Arctic countries afford to use dangerous luxury to break the ocean bottom below the Arctic Pole and to establish the oil drills, the energy crisis shall not be avoided, but only simply postponed. The global planetary problems shall aggravate and increase in a geometrical progression.

It is a paradox that at the beginning of new century, upon existing realities, showing today's *lack of perspectives in respect of the energy*, the main countries and their adjacent intellectual elite are planning next decades without taking in to account this factor! *There is setting past in the future.*

Strategies, perspectives and scenarios are developed narrow-minded on the base of past realities, solely marked with the rules set up by "Oil" world.

It is suggested the illusion that the Mankind very quickly is accustomed to high prices of the energy coming from crude oil and gas. But this is only at the "first sight" and is "one side of the medal" however deeply wrong.

The Planet and the people need new strategies, new economic and political scenarios, and new pragmatism. And the necessity of activating the research and producing of alternative types of clean energy is a mission for today and tomorrow. Whether we want or not, we are going to new energy order in the Earth, which has to take in consideration number of new circumstances of influence and necessities in global energy world.

I. THE PLAYERS

1. Oil-extracting countries

Big oil-producing countries; big countries – oil exporters, big countries oil - importers and other countries.

If we classify regionally the countries in groups we shall see approximately the following:

In the first group "A" – *oil* – *producing countries* shall be included the following subgroups: First sub-group: USA, Canada, Mexico, and Venezuela. Second sub-group: Nigeria, Algeria, Libya. Third sub-group: Saudi Arabia, Bahrain, UAE, Qatar, Oman, Kuwait, Iraq, Iran. Fourth sub-group: United Kingdom and Norway. Fifth sub-group: Russia and China and Sixth sub-group: Malaysia

In the second group "B" – *oil-exporters*, grouped again continentally are included the following sub-groups: First sub-group: Mexico and Venezuela. Second sub-group: Nigeria, Algeria, Libya. Third sub-group: Saudi Arabia, Bahrain, UAE, Qatar, Oman, Kuwait, Iraq, Iran. Fourth sub-group: Norway. Fifth sub-group: Russia and Sixth sub-group: Malaysia.

The third group "C" is including the biggest countries – *oil importers*. In the group are from one side – USA and United Kingdom, which are also oil-extracting countries and from other: Germany, France, Italy, South Korea and Japan - as clear consumers.

The fourth group "D" includes all countries from the rest of the world which are only *oil consumers*, but are the countries which positions are not taken in consideration from others – from previous groups - while taking global world decisions.

The analysis of the proposed structure of the "oil countries" showing the set up basic inequality – natural, economical and political. The only real determinant factor for the standard and ability for exercising of influence of particular country to the great degree is connected with belonging or not to the particular group of the "oil world".

It is obvious that some of the big countries belong to 2 or even 3 of the so differentiated groups. No doubt, we are far from the suggestion, that the countries from groups - A, B and C are equally unified and aiming the prosperity of the mankind and even to their population. Each group and sub-group is leading by different and some times opposite strategies and targets.

In similar manner can be grouped gas extracting countries, also exporters and importers.

2. OECD and OPEC

In nowadays global world, leading factor for influence represents organizations of groups of countries, created with particular strategic and economical targets. Such groups are for example the Organization for Economic Cooperation and Development

(OECD) and The Organization of the Petroleum Exporting Countries (OPEC) from so called "Third world". At first sight these are completely different organizations, the first OECD includes countries members of EU, Canada, USA and Australia, as well as gravitating serious partners like Norway, Japan, South Korea and Turkey. The OECD in practice is one wide spectrum of market space, leaded by common principles and global interests, including in the fields of energies. From the other side OPEC is established during 1960 nearly by reflex in order to defend it interests and more particular to co-ordinate and determinate oil prices in the world market. It should be mentioned that during last decade, OPEC goes slowly to decay, and the "Third world" is already not so united. From this world jumped the "genie in a bottle" - the Terrorism.

Notwithstanding of it problems the both organizations per today continuing to be real and serious factor in determination the policies and oil prices, as well as the perspectives for development of this sensitive for the planet, economical field – the energetic.

3. Transnational companies

Amoco, Exxon-Mobile, Shell, BP, Chevron- Texaco and the others, famous as the group of "seven sisters" accumulated considerable funds and technological resources during the long time aggressive presence in world oil market. The influence of these elite even in today's world is extremely high but even in this community there are signs of beginnings of crisis.

The reason – the protectionist and nationalistic policy of the serious oil producing and oil exporting countries like Russia, OPEC and others. The Companies have their presence and they are working at biggest oil fields of the world, they keep to the certain extent with the money and experience producing countries with contractual "holds" but this is becoming more and more difficult.

4. National companies and playing of Russia

To this group are moving rapidly Russian - Rosneftgas, Rosneft, Gasprom and the others, which during recent years come out actively on foreign markets. Their market behavior is extremely aggressive and keeps the mark of close commitment with causes outside of the business, the connection with past policies of the country. Demonstrative and in the darkness signature of the Contract for the project "South Stream" with Bulgaria, in it capacity of the EU and NATO Member, followed by immediate binding with Serbia with the project is a new evidence of the planned policy of the power and challenges. For the sake of correctness it should be mentioned that the main partner of Russia to the project "South Stream" is Italy - EU and NATO member, who sign bilateral memorandum for building and exploitation of "South Stream" on 23 June 2007. It is improper the countries to this project to determinate passing of the Stream through sovereign countries without asking for their consent according to corresponding rules. The high-ranking officials from Russian companies, periodically are gaining leader positions in the government administration and opposite like Viktor Chernomyrdin in the past and Dmitry Medvedev(new Russian President) today (or Condoleezza Rice in USA form the politics in Chevron and after back). The Russia and it monopolistic companies more and more rejecting to share their base of energy resources with foreign partners.

To the world energy market at the present hypothetically is coming new international cartel – "Gas OPEC". The initiative is coming from Iran and to the certain extent from

Russia which is trying to attract in such organization regionally distant - Libya, Algeria, Qatar and some ex-soviet republics. This Iranian and Russian action is mostly provocative and is a part of the psychological war with the West. The solely common between these countries – gas-producers is their undemocratic government system, merged with monopolistic business structures. The chance is that in Russia there is realists-pragmatics with influence, who shall not allow being destroyed the relations with the main consumer – EU, one reliable and well paying client, and why not with USA as well.

5. Terrorist Chains

Al- Qa'ida and similar organizations today, as well as some other historical nests of world terrorism "rose" like ugly child of "oil world". The main sources of financing the operations of today terrorists are coming from the oil profits. Only after that are coming the drugs. The Petrodollars gives and giving blood of this hardy phenomenon, which under the green flag of the Islam is developed to one virtual, but with real parameters and results permanent world crisis. The bases of world terrorism are in unstable Islamic countries, like Afghanistan, Pakistan and today Iraq as well as some territories of Russia. In these areas there is oil or they are in the way of the oil. *The world terrorism today is other name of Third World War*.

The world players irrespective of their different interests should take in to consideration this experiment - working already long time and to clean it up from the Earth. And to continue to one new even disputed direction, looking forward to one direction but on clean. Of course if this is still possible?

Until this time the real- factor "terrorism" should be taken in consideration in great energy projects with heightened attention. Each big energy project as a rule should have technological part and budget "Anti- Terrorist security".

6. Has European Union the energy strategy, where remains the Euroatalntism?

"May be Europeans do not always like it, but the America (USA) is still the most important for their security (Economist)."

More and more leaders of today's Europe in the face of EU, to one or another extent showing their ambition to emancipate from USA influence and the Atlantism.

In nowadays speedy world, planning of energy strategy is always delaying from the realities of the crises, extremely obvious is the delay of EU. The prognoses at this stage becoming more difficult and dependent from various situational conditions, coded at not correct partnerships and temporary advantages.

What EU is doing? In the Document MEMO/07/07 from 10 January 2007, Brussels is said:

"Energy Policy of Europe: The Commission is coming closer to resolving the energy problems and challenges of 21 Century. In the ground of new European policy is sitting to decrease the heating gas emissions during consumption of energy.

Unfortunately in this document as well as in many other documents of European institutions is becoming visible naïve declaration of the targets, missing of strategy and long term pragmatism, or how we shall reach the targets together. By principle in EU is observed as a whole inflation of laws by means of issuing Euro directives and

other laws. But in the sector energy policy there is not prepared even one Draft Document?

EU already is considerable conglomerate of countries and it is indispensable to be searched and approved principal policies with cross border orientation, especially when there is a speech for energy policy and ecological problems of one community without considerable nature including energy resources. At present moment the EU and it body – EC having no compulsory entered in force laws for performing of mutual energy policy of member countries. There is missing also adequate organisational structure for realization of this extremely important priority policy.

The big and small member countries of EU are searching for own ways to reach juncture agreements with energy producers. And this is at the moment of raising world energy crisis. That is setting up the beginning of the erosion of the Community before completion of it consolidation.

The clearly visible is heavy bureaucratic inertness and slow mobility of European institutions. It is a must that they come out from lethargy "ostrich policy" in which they dive themselves. It is not safe but it is also not correct the Europeans to remain only observers of the efforts which USA is making to obtain it own and European interests in the field of energies.

Euro Atlantic model which born the European Union is too early to be sent to the history. European personality of the Union can be proved strategically only in planetary plan, moreover that will not be in contradiction with the principles in the agreements of Rome and Maastricht.

European Union is doomed without euroatlantism.

7. Passing on "the torch" and change of strategies

As a whole, the former big players, without exclusions, controlling the governments in particular countries - a harmoniously under distance or roughly and demonstrative. This is a question of traditions, culture and political practices in particular countries.

And after all, there should not be forgotten that at today's order of the planet is going.

And after all, there should not be forgotten that at today's order of the planet is going quick re-structuring of financial and banking capital. The global world needs new global companies, global strategies, and why not a new global currency.

Today's transnational and national monopolistic companies tomorrow shall be too small to take global responsibilities and challenges of the economy and power engineering of the tomorrow world.

The "New Players" shall become these who succeed to quickly overcome commitments with strategies, policies and technologies of the status quo. There is no longer a matter of surviving and accumulating funds but for building of new future. The solitary players have no future. Grouping and consolidating of companies and states is the way to which might be meet new challenges. Strictly continental and economical business unions shall dropping out in global competition. The structures which shall have a future are these of Euro-Atlantic types but restructured and programmed towards next generations.

II. THE CONSUMERS

Out of the above mentioned group of world players in power engineering is sitting the rest of the world. The majority of the countries and the Mankind are forming the main and suffered consumer. These countries and their population without having oil fields and gas fields are dependent on the rules of "oil world". Way of living, the whole economy and everything which is connected with surviving and prosperity of particular human and country are bound by dictation of today model of power engineering. This is the World outside the circle of the Players. We may call it subjectively "New Third World"?

Who they are and what is common and what is different? These countries might be grouped approximately as follows:

A. transporting countries

In this group might be included the following countries:

- 1. These countries, in which territory there is no oil extracting, but they agreed with transportation of oil or gas and there are existing streams and installations.
- 2. These countries, in which territory there is no oil extracting, but they commit by agreement to allow streams for transportation, but these are still not realized and there is no existing transport of energy.

B. Consumer countries (huge number)

This is the biggest and most dependent part of the countries. Or these are the countries, having no it own energy source and having no chance to be on the way of the oil or gas, due to it position and calculated unprofitableness or the process.

C. The People (Mankind)

This group is conditional and includes each particular human, member of the human society, irrespective to which of the above mentioned groups he belongs. But all of them are ultimate consumers of energy, all of them are quite sensitive with their personal and family budgets from the movement of the oil prices.

The new Planet future is a reality of mutual joining of the interests of the Producers and the Consumers.

III. PIPELINES AND TRANSCONTINENTAL PROJECTS

The serious oil fields are concentrated in few areas of the Earth: the Near and Middle East, Russia and ex-soviet Middle-Asian Republics, North Africa, North Sea and Gulf of Mexico. These are most exploited places, producing the biggest world extraction of oil and gas. During number of decades, the energy transportation was performed by tankers, today the pipelines more and more are coming like new highways for energy transportation. *The natural directions of pipelines are towards world consumers – Europe, USA, China and India and the rest of the world to some degree*. The pipelines are extended between continents, on the bottom of the sea, across the countries which have hostilities and even being at war. All humans their way of living and countries consuming more and more energy, the top limit of the consumption is moving up and up uninterruptedly.

Most topical are the operative and in the project oil and gas pipelines, controlled to a great degree by Russia. The pointers of these pipelines are situated mostly toward Europe. There are South and South-East branches serving not only European countries and companies but North-American companies and Fleets. "Blue Stream", "North Stream", "South Stream"

NGPI (Nabuko Gas Pipeline International), AMBO (Albanian Macedonian Bulgarian Oil Corporation), Bourgas-Alexandroupolis, and others crossing East Europe Westwards.

What we have available? Pipelines, built decades of years ago, operative at the moment and owned by the countries they are crossing. And all of them – technologically and morally outdated and not coordinated with the index of "anti-terrorism security". And new projects, which are to answer to number of questions and new requirements – commercial, economical, ecological and in connection with anti-terrorism and global security.

IV. THE EXPERTS (WHAT THEY ARE THINKING)

The expert research and opinion in recent world has more and more crescent importance. But here is not a talk about opinion of particular group of experts. Customarily, with expert opinions, prognoses and strategies are coming international and national analytical institutions.

The UN experts during recent decades accomplished serious volume of work. This activity was with the purpose towards planetary problems connected with pollution and global warming. The great achievement is this connection is signing and entry in force of the Kyoto Protocol. *Behind all conclusions of the scientists is seen through the Oil World*.

We may exemplify the problem with one research of "Arctic Climate Impact Assessment" from 2004. **988000** sq.km. of ice cover of the Arctic was thaw during last 30 years! This is two times the territory of France.

Another aspect of analytical-prognostic activity is made by some national Agencies in USA and other countries as well as similar work outs of international Agencies. The targets of their interests and global prognoses is briefly the political conduct of big players, of group countries, but without going out from the real world we are living today and probably we shall live tomorrow. Based of these analyses, recommendations and prognoses can be made conclusions and to be argued market and ecologically oriented behavior also towards future of energy problems in planetary plan.

V. THE PROBLEMS

In general plan there are observed groups of economical, technological, ecological and global (planetary) character. There are outlined uncontrolled to the certain extend crises in few directions:

- * crawling energy crisis, crisis of US Dollar(The World currency), mortgage crisis in USA (which is on it way to "infect" the economics across the ocean), stock exchanges crisis, local warlike conflicts and increasing terrorist threat are the connected accents of today's problematic world;
- * lack of adequate investments and willingness to invest in technologies, which have to survive the Planet and Human, helping for absorption of world crisis;
- * global warming as a result of entire pollution with all adjacent consequences for ecology and Earth future;
- * absorption of the process of confrontation of nowadays concepts of civilizers' values and leadership, the conflict "Islam Christiandom".

VI. WHERE IS THE WAY, THE MODEL? "THE FIFTH SCENARIO"

The offensive of "New" Asia, including China and India, shall design the future world during next 20 years. According to the prognoses of serious analytics during these years the consumption of energy (mainly oil) shall be increased by 50%! *The new economic role of China, India and as well Brasilia in their ambition* towards active presence in the markets shall result in not so controlled exploitation and exhausting of world energy resources. Today's big "players" more and more will have to in to consideration potential tomorrow economical "dinosaurs" which they willing or not must invite in their "club". But ones and the others are looking to tomorrow world from the prism of recent "Oil World".

One is obvious – the consumption of oil and gas shall increase without control. The world players and the producers shall put their prospecting drills in each reachable place of the world. Where the Earth is going to, what the target priorities of the Mankind are?

The terms of reference in this connection is giving to us the fundamental work of the National Intelligence Council's (NIC) of USA in "Mapping the Global Future". This consultative body, primarily consisting of staff from Central Intelligence Agency (CIA) and elite university experts, presented third Report with prognosis period of about 15 years. The authors prepared hypothetical "scenarios", which are not exactly expectations, mostly they describing possible worlds to which we may land depend on which one of the subject tendencies shall be developed and shall interacting:

- *The world according to Davos*, illustrating the manner according to which during next 15 years one strong economic growth, on which base shall be China and India may remodel the globalization as well as to give non- western appearance and cause changes in the politic field;
- **Pax Americana** examines the way under which the supremacy of USA would overcome the changes of world and political landscape and to contribute in forming of new and more varied world order;
- *One new Halifat* is giving example for world moving feeding by radical political formations, connected with religious identity, which if become base of world system, might become challenge for the rules and values of the West;
- *The cycle of the Fear*, is showing how the anxiety of spread of some weapons might result to important preventive measures for security against possible, measures, threatening to establish the grounds for one "World of Orwell";

The "Scenarios" are eventual or combined possibilities for our world and human future. In these scenarios we may see through the interests of the big players in our world. Before us are presented the theses of the problems of recent World, developed hypothetically in the time until conversion of each one in rules of competition, to world dominant. At so presented scenarios it is visible the firm determination of world players to reach the end of their targets. Under all 4 scenarios even if under combination on it realization for the future world, this will be again old "oil" world.

Only unknown remains: who shall be the winner and what the consequences shall be.

THE ENERGY SOURCES AND STREAMS – MUTUAL PATRIMONY AND PROPERTY OF THE MANKIND

These scenarios are missing the view from the other side – human surviving and prosperity, the perspective. Missing "The Fifth Scenario" i.e. *missing the criteria for surviving in crisis*, the fact that the Earth with their exhausting natural resources is

priority, that the Earth is *mutual patrimony and property of the mankind*. There is missing the Alternative of pragmatic, useful action.

The topic of resources and adjacent ecologic and climate changes of the world and new energies, inevitably shall remove from the agenda the problems connected with our commitment with "Oil World". *The World and Human have no future in running dry Oil marsh.*

THE MODEL

The Model is only hypothesis but before all working plan and responsibility.

Recent experience and practice in application of formula "mutual patrimony and property of the Mankind" is created on the basis of United Nations Convention on the Law of the Sea, accepted during 1982, entered in force from 1994. Practically, this unique convention created equitable model for research, exploitation and managing of natural resources situated at the sea bottom and womb of the World Ocean.

The philosophy of this model is set up during far 1608 from Netherlands lawyer Hugo van Grotius who in short charter announce "freedom of open sea" and invoke the countries to own only that sea they may defend.

After more than 350 years (during 70- ies of the past century) Maltese Arvid Pardo under General Assembly of UN made his historical proposal for perspectives of development of ocean bottom and shelf as mutual and may be last life perspective of the Mankind".

Still at the middle of the last century the scientists observed dramatically decreased raw-material resources of the continental part of the Earth. Two ways are outlined, which might be followed separately but also simultaneously.

One way, the nature is giving us various possibilities for extracting of resources and production of energy, through transforming of wind, biomasses, water and sun. That is the way which should have priority.

Modern technologies and technical means, are giving the possibility to be produced energy from the process of restoration sources; which to be about 6 times more than necessary in worldwide measure, for example:

Sun -3.9 times Geothermal sources -1 time Wind -0.5 times Biomasse -0.4 times Hydrodynamic -0.15 times Oceans -0.05 times

The other way chosen by UN, where the objects of satisfying of needs are resources of sea bottom and it wombs.

And the Third Conference of UN on Law of the Sea drafted *the MODEL*, who set up the following principle postulates:

- 1. *International Region* includes "sea surface and ocean bottom and it wombs over the limits of national jurisdiction"
- 2. "Resources", means all solid, liquid and gas mineral resources in the Region, situated to the sea bottom surface or behind it, including polymetallic concretions.

3. "The Region and it resources are mutual patrimony of the mankind.

- No country may pretend to have sovereignty or sovereign rights or to execute such rights over any part of the Region and it resources;
- No country or person or legal person may not appropriate any part of them;
- No pretension of any type, no type of execution of sovereignty or sovereign rights, and no similar appropriation shall be recognized;
- All rights over the resources of the Region are belongs to the all Mankind.

4. For the welfare of the mankind

- The activity in the Region shall be performed in favor of all mankind, irrespective of geographical position of the countries whether coastal or without having sea borders;
- The region shall be placed at disposal only for peaceful aims of all countries;
- The activity in the Region concerning the resource deposits situated over it borders, shall be preformed while taking in to consideration the rights and interests of each coastal country in which jurisdiction are situated these resources.

This model represents the existing International Law. The principles and rules built on it are mandatory regulator for conduct of the countries, physical persons and legal entities concerning research of the sea bottom or it fields for all world ocean, outside the limits of their exclusive national jurisdiction.

This model has one hidden danger – to put the mankind in competition for a long time period. It might be disastrous for the Earth if it is not controlled – The United Nations Convention on the Law of the Sea is giving such a possibility.

Increase of dynamism of the crises and obvious disregarding of the rules by the world players, makes necessary the activation and development of the Model. In Earth order of the day is necessary to be drafted model for New World Energy Order (NWEO) concerning using and protection of natural resources and usage of energy resources.

STAGES OF STEP BY STEP MODEL

I. PERFORMING OF RECET MODEL AND RESPONSIBILITIES

It is necessary to be used recent planetary model of legal frame for research and exploitation of natural resources (including oil and gas) by using the instruments of UN. Of course by clarification that there is a talk about exploitation of sea bottom and it wombs, outside the limits of national jurisdiction, which is in accordance with United Nations Convention on the Law of the Sea. Irrespective of the crisis covered universal world institutions, *it is obvious that there must be used the UN model and Rules made in order to be avoided hypothetical interstate conflicts*. The problems and the rivalry should be decided by negotiations and reaching of agreements according to binding international law. And the realities to be kept constantly in to consideration – the environment condition and it future.

II. DETERMINATION OF THE NEW TARGETS

- 1. Once again recognition of the UN as universal international body, solely able to realize the model of New World Energy Order;
- 2. Activation and engagement of the world players in building and control of New World Energy Order. The must be no dividends from mutual patrimony without participation;

- 3. Building of world harmonized energy network for producing and transportation of clean energies;
- 4. Differentiation of strategic planetary fund of the recourses and new energies at UN, who on the basis of long term planning to grant concessions (licenses) for exploitation;
- 5. Announcing through UN of the strategic resources of the Earth as Mutual property and patrimony of the mankind, which is researched, exploited and controlled under special international regime;
- 6. Accelerated and with priority tuning of the power engineering to clean natural and cosmic sources and gradually development of new in principles Sun power engineering, based in practice on inexhaustible sources;
- 7. Development of the system of International rules for harmonization of national legal systems by realization of New World Energy Order.

III. THE PRINCIPLES OF FINANCIAL PLANNING, PRIORITIES OF INTERESTS AND COMPENSATORY SYSTEMS

- The idea of New World Energy Order has no target to bankrupt world and national corporations and particular countries, engaged with nowadays way of research, exploitation and producing of the energy.
- Accepting of realization and control of NWEO by UN, shall save huge finance funds, which is needed for building of special body, as well as shall use recent experience and legal instruments of the Organization.
- The financial resource of energy corporations, like the budgets of particular countries and World organization (UN), should be planned and redirected to harmless technologies and simultaneously to be built special compensatory plan for the investors.
- In practice the world players should invest considerable part of their finances in technologies for "new energies";
- Against that they have to obtain long term tax and other advantages, but by undertaking long term contractual obligations and after purchasing of concessions(licensing) rights;
- To be developed comparative finance and technological analysis, connected with budgeted presentation of the two ways of using the resources clean energies and sea bottom.
- To be developed a system and particular Plan Budget for development of the countries with weak economies, as well as for these which have no natural resources;

IV. OFFICIAL INITIATIVES OF UN

The secretariat of the World Organization, to initiate in accelerated way pragmatic actions and present to member countries package of initiatives before General Assembly and the governments of member states in following directions:

- 1. EXTRAORDINARY SESSION of GA of UN for the problems connected with global heating, climate, resources and world power engineering (new energies);
- 2. Accepting of MORATORIUM for extraction and exploitation of oil and gas, as well as other minerals form the bottom of Arctic (Decision, Resolution of UN and GA of UN);

- 3. Accepting of SPECIAL STATUTE of ARCTIC (similar to this of Antarctica);
- 4. Setting down time for Conference of UN FOR THE PROBLEMS OF POLLUTION AND NESSESITY OF BUILDING OF NEW WORLD ENERGY ORDER (NWEO), which to end with UNIVERSAL CONVENTION of UN in this direction;
- 5. Establishing of the FUND at UN for the resources and new technologies in power engineering;
- 6. Building of permanent body at UN Committee for building and management of NEW WORLD ENERGY ORDER;
- 7. Building of National co-coordinative committees for the activity of for particular countries;

The present authorship proposal for the Model of NWEO is only one pragmatic step, towards deciding of global and not for postponement problems of the Planet. The problems created by the Human. The topic is open for discussion, but the time clock is running. There is an urgent need to be made next coordinative steps with unanimity towards the future. All of us we have to enforce our will in the name of the living future of the Planet.
